The Tender without EMD will summarily be rejected without assigning any reasons thereof. The Tenderers shall have to write their names and address with Sl. No. of works & NIT memo no. on envelop otherwise the Tender may not be opened at all. Tenderers should inspect the site and acquaint themselves with difficulties and peculiarities if any and quote their rates accordingly. No Claim in this regard will be entertained in future.

Tender paper will be available from the office of the undersigned as following. No tender paper will however be issued on the date fixed for opening the tender. Registered Labour Co-Operative / Engineers Co-Operative Society should furnished their latest certificates along with the Tender duly attested by Assistant Registrar of Co-Operative Society along with resolution passed by the society to participate in the Tender beside fulfilling other criteria.
